AUCTION RULES

The All-New Electric SUV XUV400 Limited Edition (#OneOfOne) Auction

The Auction Rules are to be read along with the Mahindra XUV400 Auction User Agreement available at <u>https://auction.carandbike.com/home</u> and are subject to the terms and conditions of the Mahindra XUV400 Auction User Agreement. Any and all capitalized terms appearing in the Auction Rules are defined in the Mahindra XUV400 Auction User Agreement.

1. <u>Timelines for the auction</u>

2. <u>Registration Process</u>

- (a) You may register for the auction during the Auction Window through the URL <u>https://www.carandbike.com/auction-registration/xuv400</u>
- (b)The registration page will request the User to provide details such as:
 - a. User Name
 - b. Mobile Number / User ID (Unique)
 - c. Email ID (Unique)
 - d. City
 - e. Password
- (c) Once you enter and submits the requisite details, you will be redirected to an OTP verification screen and an OTP will be sent to the mobile number entered by the User in the previous registration page. The User has to successfully verify OTP to complete this step.
- (d)Upon successful OTP verification, the User will receive a welcome SMS on the registered mobile number entered by the User

(e) Post OTP verification, you will be redirected to a payment screen where you will be required to pay the Caution Money along with accepting the terms and conditions of the Mahindra XUV400 Auction User Agreement.

(f) You will have to accept the Mahindra XUV400 Auction Agreement to proceed for payment. Your acceptance of the terms and conditions while paying the Caution Money by clicking on the tick box, confirms that that you have read and understood the terms and conditions related to the auction.

- (g) The Caution Money payable by you to register for the auction is Rs.10000 (<u>Rupees</u> Ten Thousand Only) and is subject to the terms of the Mahindra XUV400 Auction User Agreement.
- (h)Once the Caution Money is paid, you will be classified as a Registered Bidder and will be able to participate in the auction.
- (i) You will not be allowed to participate in the auction without payment of the Caution Money.

3. <u>Auction Process</u>

- (a) The auction room will be open only for the Registered Bidders who have paid the Caution Money and such Registered Bidders may enter the auction room using the URL_http://auction.carandbike.com.
 - (b)The Auction Window opens on 26th January 2023 at 11:00AM IST and closes on 31st January 2023 at 11:59 PM IST.
- (c) During the term of the Auction Window remaining open, a Registered Bidder may place bids in multiples of Rs.25000 (Rupees Twenty Five Thousand Only).
- (d) Whilst the Winning Bidder will be awarded no more than one (1) vehicle, the Registered Bidders may place unlimited bids during the Auction Window on the platform in bid increments of INR. 25,000 (Rupees Twenty Five Thousand)over and above the Reserve Price set by M&M i.e the Registered Bidder may place bids during the Auction Window in multiples of INR 25,000/- (Rupees Twenty Five Thousand) only.
- (e) M&M, at its sole discretion may either reduce or increase the bid increment limits from INR 25,000(<u>Rupees</u> Twenty Five Thousand) at any time during the Auction Window without notice to the Registered Bidders.
 - (f) The bids for the vehicle may be placed by a Registered bidder till the closing time of the Auction Window.
- (g) You agree to be aware that, M&M has placed a reserve price (a minimum selling price for the vehicle on auction which hereinafter is referred to as the "Reserve Price") on the vehicle being auctioned. The Reserve Price on the vehicle throughout the Auction Window will be INR 25,00,000 (Indian Rupees Twenty Five Lakhs Only). Bids may only be placed by the Registered Bidders over and above the Reserve Price.
- (h)A Registered Bidder may put in unlimited bids for the vehicle over and above the Reserve Price.
- (i) Periodic SMS related to status of the bids will be sent to the Registered Bidders participating in the auction.
- (j) Subject to these terms and conditions, the Registered Bidder, whose bid has, met and exceeded the Reserve Price and has placed the highest bid at the end of the Auction Window i.e. 31st January 2023 11:59 PM IST will be Winning Bid and the Registered Bidder with the Winning Bid will be adjudged as the Winning Bidder by M&M. Subject to the terms and conditions appearing under the Mahindra XUV400 User Agreement, on conclusion of the bidding process the Winning Bidder's bid shall form a contract for sale between the Winning Bidder and M&M, which unless otherwise specified in writing by M&M, shall incorporate these terms and conditions.

4. Announcement of the Winner

- (a) M&M will publicly announce the name of the winner of the auction on 10th February 2023 11:59 PM IST.
- (b)On conclusion of the auction and after the end of the Auction Window, FGVL and/or M&M will notify the Registered Bidder by SMS, phone call or email (the "Notification") of whether the Registered Bidder has been declared as the Winning Bidder. Registered Bidders who are not adjudged as the Winning Bidder by M&M will be notified to that effect by way of SMS or email. The Registered Bidders will be contacted on the registered number/ email id which shared with FGVL and M&M by the Registered Bidder at the time of registration.
- (c) Authorized representatives of M&M will try to contact the Winning Bidder on a best effort basis and calls will be made to the Winning Bidder on 1st February 2023 during business hours. In case of no-response from the Winning Bidder by end of business day on 1st February 2023, the Caution Money paid by such Winning Bidder will be forfeited and the next highest bid will be declared as the Winning Bid by M&M and the Registered Bidder who placed the said bid will be adjudged to be the Winning Bidder. The aforementioned process will be followed till a Winning Bidder fulfills all the payment and KYC requirements as mentioned under this Mahindra XUV400 Auction User Agreement.
- (d) You agree that only the communication received by you from emails containing the domain name "@mahindra.com" shall be treated as a valid communication from the authorized representatives of M&M and that you shall not act upon any other email, telephonic or SMS communication received from any other phone number or e-mail address claiming to be that of an authorized representative of M&M. If an authorized representative of M&M calls you through any phone number, such authorized representative shall send you an email with the domain name "@mahindra.com" recording the telephonic conversation.
- (e) The Winning Bidder upon receiving a call from the authorized representatives of M&M shall be informed by such authorized representative of the steps to be taken by the Winning Bidder in completing the payment as per the Winning Bid and in completing the KYC (E.g. PAN Card (mandatory), Voter ID/ Driver's license/ Aadhar Card) required to register the vehicle in the name of the Winning Bidder. The Winning Bidder may also be required to provide a declaration confirming their intent to make the payment for the amount declared as the Winning Bid and providing all the required documents within the specified time period
- (f) The Winning Bidder will deposit an amount of Rs 25,00,000/- (Rupees Twenty-Five Lakhs only) ("Reserve Price") by end of business hours on 2nd February 2023, and the balance payment as per the Winning Bid shall be made on or before 5th February 2023. Payment of the afore-mentioned Reserve Price will be made in favour of Mahindra & Mahindra Limited. The payment mode will be Bankers Cheque/ Bankers Draft or an online NEFT / RTGS transfer in favor of Mahindra & Mahindra Limited. The bank account details to which the payment is to be made will be communicated by M&M in its communications to the Winning Bidder. The payment mode and the account details for payment of the Charity Money to the Charitable Organization will be communicated by M&M in its communications to the Winning Bidder.
- (g) The Winning Bidder shall submit post-dated cheques for the remaining amount as per the Winning Bid (which is the balance of the Winning Bid and Reserve Price submitted), which shall be encashable by M&M on or before 5th February 2023. The winning bidder understands that dishonour of these cheques is a criminal offence. In case of failure to pay such amount by the date specified herein, the Caution Money and Reserve Price will be forfeited and the next highest bid for the vehicle received by M&M may be adjudged

as the winner of the auction by M&M.

- (h) The Winning Bid amount paid by the Winning Bidder will be accounted as follows;
 - a. An amount equivalent to and inclusive of the price towards the ex-showroom price of the vehicle, the registration fees, the insurance charges and any other local levies as decided by M&M will be retained by M&M along with the Caution Money paid by the winner of the auction (hereinafter referred to as the "Vehicle On-road price").
 - b. Any amount received in excess of the amount calculated by M&M towards the Caution Money, ex-showroom price of the vehicle, the registration fees,

insurance charges, and any other local levies (hereinafter referred to as "Charity Money") will be paid by the Winning Bidder directly to the charitable organization of his/her choosing (hereinafter referred to as the "Charitable Organization")from the options given to the Winning Bidder by M&M. Such Charity Money paid by the Winning Bidder directly to the Charitable Organization will not be a part of the on-road sale price of the vehicle and hence will not be reflected in the invoices received from M&M.

- (i) Upon payment of the complete amount quoted in the Winning Bid by the Winning Bidder and upon providing the required information as per the KYC requirements imposed by M&M or its dealers, M&M will register and deliver the vehicle through a local dealer of its choice to the Winning Bidder.
- (j)For the Winning Bidder, true and accurate KYC after being adjudged the winner of the auction is a MUST. Refusal to complete the KYC requirements imposed by M&M within 5 days of the Notification will result in the winner of the auction forfeiting the Caution Money and any other amount so deposited by such person.
- (k) A bid once placed by a Registered Bidder may not be retracted and the Registered Bidder is bound to complete and pay the amount bid by the Registered Bidder if that bid is the Winning Bid. The Winning Bid will be inclusive of all the taxes payable under applicable laws.
- (1) The vehicle won by the Winning Bidder in the auction will be invoiced and registered only in the name of Winning Bidder or in the name of a close relative. Transfer or change of name at the time of delivery / registration is not allowed. Please check the Mahindra XUV400 Auction User Agreement, for more information.

5. Choosing the vehicle and the Charitable Organization

The vehicle won by the Winning Bidder will contain the following features;

- (1) New signature Blue body colour designed by Rimzim Dadu, along with copper roof and piano black roof rails
- (2) The piano black alloy wheels, further accentuated by the exclusive Rimzim Dadu X Pratap Bose engraved logo in copper
- (3) The C Pillar is also branded with the logo
- (4) Fog Lamp

- (5) leatherette seats with new blue regular perforation and copper deco stitch along with embroidered branding
- (6) The steering wheel also comes wrapped with copper deco stitching
- (7) On the second row armrest, you will see copper embroidered branding and metal plated seat, along with back seat storage string with the RD x Bose logo
- (8) On the infotainment system, the exclusive edition comes with a new welcome screen branded with the RD x Bose logo
- (9) Exclusive Spotify playlist pre-loaded with favourite chartbusters of Pratap Bose and Rimzim Dadu
- (a) Please note that vehicles colour displayed on Mahindra XUV400 website may slightly differ_from the actual colour of the vehicle.
- (b)Upon declaration of the Winning Bidder, the Winning Bidder will be required to send a confirmation email to that effect.
- (e) The vehicle won through the auction will be delivered to the Winning Bidder within a maximum of 60 days from date of M&M receiving the full and final Vehicle On-road price and the Charitable Organization receiving the Charity Money as per the Winning Bid amount either directly from the Winning Bidder or through their bank subject to fulfillment of the KYC requirement imposed by M&M and after registration of the vehicle in the name of the Winning Bidder. Upon payment of the Vehicle On-road price and the Charity Money to M&M and the Charitable Organization respectively, the Winning Bidder will have to produce proof of such payment to M&M. M&M will within 5 days of you producing such proof of payment, cross check the payment details with its own records and with the records of the Charitable Organization. The vehicle registration and delivery to the Winning Bidder will be done by M&M only after M&M receiving confirmation from the Charitable Organization of having received the Charity Money.
- (f) For those Registered Bidders who had paid the Caution Money but did not win the auction, the refund of the Caution Money will be initiated immediately upon such Registered Bidder receiving the Notification to that effect. Such refund will be made by the third-party payment gateway to which the Caution Money was paid by the Registered Bidder. Refunds shall be made back to the same source from which the Caution money was paid within a maximum of 30 days from the date when the Registered Bidder received Notification by FGVL that the refund has been initiated.
